

## **CONSENT**

### **for the Processing of Personal Data**

#### **1. Personal Data Subject**

The Personal Data Subject under this Consent is a user of the Website [www.logistika-expo.ru](http://www.logistika-expo.ru) who has completed a form and provided their personal data (surname, first name, patronymic, telephone number, email address (e-mail) and other information specified in the form).

#### **2. Personal Data Operator**

I, being the Personal Data Subject, give this consent to **LIMITED LIABILITY COMPANY "SIGMA EXPO GROUP"** (TIN 7743378236, PSRN 1227700183215, address: 125504, Moscow, Dmitrovskoye Highway, building 71B, floor 6, premises 4/6), registered in the Register of Personal Data Operators No. 77-22-085505 (hereinafter referred to as the "**Operator**").

#### **3. Purposes of Personal Data Processing**

This consent is given by me to the Operator for the purposes of:

- preparation, conclusion and execution of civil law contracts between me and the Operator, as well as consideration and coordination of the conditions of my participation in exhibition, congress and other business events organized by the Operator;
- registration and processing of applications submitted by me through web forms on the Website [www.logistika-expo.ru](http://www.logistika-expo.ru), including applications for participation in events, space booking, service requests and other inquiries, as well as subsequent communication using the specified contact details;
- organization, preparation and conduct of exhibition, congress and other business events, including notification of application status, participation conditions, program, schedule changes and event results;
- providing me with access to services and functionality of the Website related to viewing information about the Operator's events, participants and services, as well as processing my requests and inquiries through Website forms and contact details specified on the Website;
- registration and management of subscriptions to the Operator's informational mailings about events, services, changes in service conditions and other news about the Operator's activities;

- processing my personal data for the purpose of promoting the Operator's services and sending me advertising and marketing information about the Operator's events and services, subject to my separate consent to receive advertising via telecommunications networks;
- maintaining internal reporting, statistics, analyzing event effectiveness, collecting anonymized statistics on Website traffic and User behavior to improve the quality of the Website, its services and the Operator's business events.
